TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australia residents located in WA, SA, NSW, QLD, VIC, TAS & NT 18 years and over ("Eligible Entrant").
3. Employees (and their immediate families) of the Promoter, participating distributors and agencies associated with this promotion are ineligible to enter.
